Objectives and investment policy

Objective

The fund aims to provide a return consisting mainly of income but with some capital appreciation by actively managing the fund's investments across predominantly passive strategies in a diverse range of asset classes and sectors.

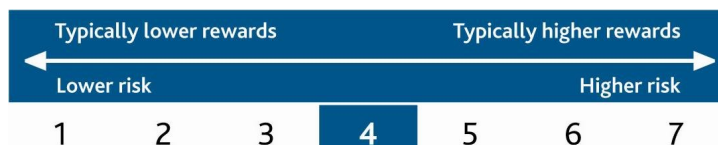
Investment Policy

The fund invests mainly in shares or other instruments, including collective investment schemes, which follow passive strategies, that is strategies designed to track the performance of particular share market indices, market sectors or asset classes.

Essential features of the fund:

- The fund has the discretion to invest in a range of investments as described above.
- The fund's performance is measured against the IMA Mixed Investment 0-35% Shares Sector.
- The fund has no specific target market, asset class or geographic sector.
- You can buy and sell shares in the fund on each business day.
- The fund aims to distribute available income every six months.
- The AAP in the fund's name means Asset Allocated Passives and refers to the investment strategy described in the Objective above.
- Derivatives are used to reduce risk by hedging against currency movements in the value of investments held in the fund.
- Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

Risk and reward profile



- This indicator shows how much a fund has risen and fallen in the past, and therefore how much a fund's returns have varied. It is a measure of a fund's volatility. The higher a fund's past volatility the higher the number on the scale and the greater the risk that investors in that fund may have made losses as well as gains. The lowest number on the scale does not mean that a fund is risk free.
- The fund has been classed as 4 because its volatility has been measured as average.
- This indicator is based on historical data and may not be a reliable indication of the future risk profile of this fund.
- The risk and reward profile shown is not guaranteed to remain the same and may shift over time.
- Credit Risk: Fixed interest securities are affected by trends in interest rates and inflation. If interest rates go up the value of capital may fall and vice versa. 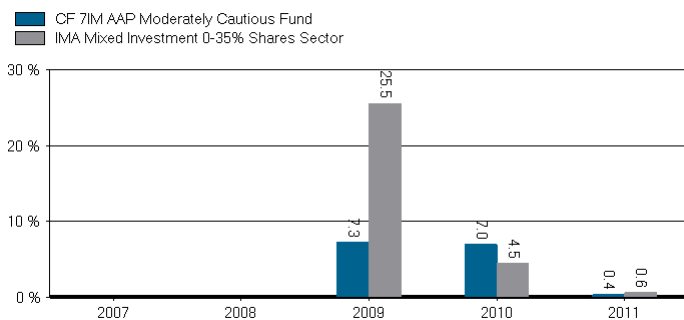
The entry charge shown is a maximum figure. In some cases investors may pay less. You can find out the actual charges from your financial advisor or distributor.
